## Turning America Upside Down From Karl Marx to Hillary Clinton and Barack Obama

Seems a bit far-out, doesn't it? Hillary Clinton and Barack Obama are in a direct line with Karl Marx to overthrow the foundations of society, as we know it.

First, Karl Marx, the founder of communism, was no reformer. A hate-filled man, who raped his own servant girl, Marx stood for "the criticism of everything" and the destruction of all institutions. The young Marx wrote: "I wish to avenge myself against the One who rules above."

In the 20th century, communism, the bloody system created by Marx, killed well over 100 million people.

Among the most dedicated communist operatives were a group called the Frankfurt School. Set up by Marxists, but located in Germany, this group of pseudo scholars fled to the U.S. in 1933 and became very influential.

That brings us to Hillary Rodham Clinton and Barack Obama, both being touted and promoted by the mass media as hot prospect candidates for the presidency in 2008. Both are well

financed—Hillary reportedly has a \$100 million war chest. Obama is backed by shadowy financier George Soros.

Hillary represents radical feminism. Obama, a mixed-race individual, raised in Indonesia and brought up a Moslem, represents the Third World assault on our values.

Subversive communist intellectuals like the Frankfurt School spread a creeping social revolution that seeks to invert the social order. It has brought the likes of Hillary Clinton, a white female, and Barack Obama, a black male, to national prominence as candidates for President of the United

Whether either one is actually nominated by the Democratic Party and elected to that office is not nearly as important as what the respective campaigns of these two contenders represent about the condition of their political party, the electorate, the media and the American political process.

## The Lynching of Jena, Louisiana

By now most of America has heard of Jena, Louisiana and the so-called Jena 6. What has been lacking from most of this dialogue however have been facts and common sense. It was not until Jared Taylor and *American Renaissance* actually made the effort to attain the facts on the ground that many began to smell a rat. While that rat wasn't exactly Al Sharpton, it was his enablers in the media, spurred on by an angry Negro populace that has sought to crucify the poor citizens of Jena and silence any last vestiges of Anglo self-confidence and identity. It is thanks to the research efforts of Mr. Taylor that I am able to bring you this story.

In the courtyard of Jena High School there is a tree which has served as a hangout point for students at the school.

While mostly white youths hung out there, it wasn't a rule of thumb that this was a segregated area, contrary to what most of the national media have reported. Instead the media chose to focus on the hanging of three nooses on August 31, 2006. The perpetrators were quickly located, interviewed, and found to have no racial motivations in their actions by the school officials, the local police, and most notably the FBI. Jared Taylor also pointed out that the local US attorney (who happens to be black), Donald Washington, found that no crime was committed and accordingly took no action. This has somehow escaped the media and the modern day lynch mob that have focused their animus on local DA Reed Walters for taking no local action on the matter. In their minds the hanging of the nooses was the true crime and not the events that would follow.

# Immigration Control and Political Reality

Address delivered at the CofCC National Conference, June 2, 2007

On May 1, 2007, Senator Edward Kennedy spoke before the national conference of the Anti-Defamation League of B'nai Brith and called for "meaningful immigration reform." The occasion for Kennedy's talk was the ADL's announcement of the re-issuance of *A Nation of Immigrants*, a short book written 50 years ago by then-Senator John F. Kennedy. The book was written specifically for the ADL and was published by the ADL in 1958.

The Kennedy brothers have served the ADL as useful front men. It is likely that "a nation of immigrants" was a topic assigned to the elder Kennedy for his purported composition. Whatever the details, the ADL launched a massive campaign in 1958 to convince Americans that the USA is only "a nation of immigrants." That phrase itself is deceptive because immigrants are people who enter a nation that is already established. The founders of the American nation were colonists and settlers, not immigrants. A "nation of immigrants" is not truly a nation at all, but nothing more than a geographical gathering place for people who use the same unit of currency.

The ADL's propaganda campaign led to the enactment of the Immigration Act of 1965, which did away with the system of national origins quotas and opened the USA to a flood of Third World immigration. The 1965 act by itself is enough to bring about the gradual destruction of the historic American nation of the founders, but the ADL and its constituency want an acceleration of that process.

Hence, Senator Kennedy has called for legalization of the illegal aliens in the USA, an increase in the number of legal entrants, and a program for so-called guest workers. He has been joined in this effort by President George W. Bush, who has the same concept of "meaningful immigration reform." George Bush has even more enthusiasm for a guest workers' program. Perhaps he wants to go down in history as the President who implemented the final solution to the servant problem.

Spokesmen for employers, such as the *Wall Street Journal* and the U.S. Chamber of Commerce, who insist that profits cannot be maintained without mass immigration, are in ironic agreement with Karl Marx. Marx maintains in *Das Kapital* (1867) that "a surplus labouring population" is "a condition of existence of the capitalist mode of production." What he calls "an industrial reserve army" is needed to lower wages and

enable profitability. Usually, this industrial reserve army consists of the unemployed, but in the last chapter of *Das Kapital*, Marx adds immigrants to the list of those who can serve that purpose.

The advocates of open borders say that labor is just another commodity, a commodity which should freely cross borders in the new world order of free trade. They again unintentionally agree with Marx. Marx maintained that capitalism treats labor, and the workers themselves, as simply a commodity. Neoconservatives and Libertarians especially want us to accept this idea that labor should be just another commodity in international commerce.

Tamar Jacoby, a fellow of the neoconservative Manhattan Institute, wrote on "Immigration Nation" in the November/December 2006 issue of *Foreign Affairs*, a publication of the Council on Foreign Relations. Affirming the ADL's concept of the USA as "a nation of immigrants," Jacoby explains immigration as an outcome of "the global integration of labor markets" and finds that "the most important statistic for anyone seeking to understand the immigration issue is this: in 1960, half of all American men dropped out of high school to look for unskilled work, whereas less than ten percent do so now." The result is a "shortfall of unskilled labor."

After decades of being told that education is all-important, we are now told that not enough Americans drop out of high school to produce the cheap labor pool that capitalism needs to survive. Michael Bloomberg, the Mayor of New York City, said something similar, according to the *Toronto Star* of July 6, 2006, when he testified to a Senate committee on immigration that "the economy of the largest U.S. city and the rest of the country would collapse if illegal immigrants were deported en masse." Thus do the neoconservatives affirm that "Ignorance is Strength."

In a survey of the general U.S. population undertaken by the Council on Foreign Relations early in 2006, only 11 percent wanted to increase legal immigration, while 54 percent wanted to decrease legal immigration. On the other hand, the C.F.R.'s survey

of 450 leaders on foreign policy issues, which included Congressmen, CEOs of major corporations, presidents of major universities, etc., revealed that only 10 percent of these leaders want to decrease legal immigration, while 33 percent want to increase it. The C.F.R. study concludes that "Immigration—widely seen as a threat to low-wage American workers and as a possible source of terrorism—draws remarkably stronger reactions from the public than from leaders." Michael Teitelbaum, writing about this survey in the April 17, 2006, *Christian Science Monitor*, concludes that there is "a huge gap between public opinion and elite opinion on immigration issues."

Public opinion should find representation in Congress, but on the immigration issue it has not found such representation. Moreover, it is unlikely that it will find such representation. Congressmen, themselves part of the elite, know all too well that most of their campaign funding comes from the plutocracy. By voting against immigration control, they know that they will please their paymasters as well as the alien lobby.

All indicators suggest that Congress will enact immigration legislation that will accelerate the nation's destruction. They will feel safe in doing so, despite and against public opinion, because public opinion has not made itself known in a politically effective manner. During 2006 and again this year, millions of demonstrators in the streets of Chicago, Los Angeles and other cities called for amnesty for illegal aliens, but the numbers of counter-demonstrators were minuscule in comparison.

It is an unwelcome fact, but one which we must recognize, that although there are at least 150 million Middle Americans, actual Middle American Radicals, rising up to take back America, have proven to be few and far between. Most of those Middle American Radicals who do exist seem to have been waylaid into the Christian Right, a safe playground from which they can boldly declare their support for the Ten Commandments and their opposition to pornography. The Middle American Revolution belongs to the realm of political science fiction.

Middle Americans are employees. As employees they are habituated to servility, conditioned to do only what they are directed to do by their employers. The civic culture of the old middle class, mostly independent farmers and craftsmen, has declined along with that class. Most Americans who are employees at will are afraid to become involved in politics, fearful of reprisals that will be taken against them through their jobs. They also have been given the idea that political activity, other than voting, is the exclusive preserve of the local elite, the members of the local Chamber of Commerce.

The only question open to debate now is how rapidly the USA is moving towards becoming a northern version of Brazil. In the absence of real resistance from the public, the scheme to abolish the southern border and to dump into the domestic American labor market the impoverished masses of Mexico, Central America, and the Caribbean will move forward. The high end of the labor market will also continue to be glutted with immigrants and visa holders from India, China, and other Third World countries. The result will be downward pressure on wages and salaries, the gradual dissolution of the American middle class and the rise of a society of two classes.

Although most Republican politicians see only the profits accruing from this policy, the political consequences should be obvious to anyone who considers the difference between California in 1966 and in 2007. In 1966, California had a Republican governor, Ronald Reagan, a Republican-dominated state government, two Republican Senators, and a Republican majority in the state's Congressional delegation. Now there is only the Republican governor, Arnold Schwarzenegger, who came into office via a non-partisan special election. Reagan could not be elected in California today.

Republicans will continue to be edged into defeat at the polls as more immigrants become citizens and begin to vote. During the past generation, Latino citizens have consistently voted 2 to 1 in favor of Democratic candidates. In the 2006 Senatorial election in Virginia, the Democratic candidate won by less than 9,400 votes. His winning margin came from the 51,000 Muslims who voted in Virginia, more than 80 percent of them voting for Democrats. (A fuller account appears in the *Washington Post* of November 30, 2006.) In Montana, the Republicans lost another Senator in a closely contested

talk show hosts the nooses incident was highlighted as if daring racial tensions to explode. Those tensions finally erupted on September 6 as a white student was assaulted from behind and sent to the hospital for stitches. Amazingly there was no retaliation, no calls for revenge, and no exceptional activities undertaken in response to this assault which was an actual crime unlike the nooses affair. The police were present on campus the subsequent day and things seemed to return to normal. It was only on November 30 when the main school building was gutted by an arsonist that anything out of the ordinary occurred in Jena. The police as of this writing have no leads on the case and no motivation for the arson has been named.

Jena High School was closed and the next few days would see racial tensions explode as members of the Jena 6, with a reputation for troublemaking, would make their presence felt. There were several off-campus fights that would involve members of the Jena 6. One of these was at a private event at the Fair Barn on December 1, where several black students from Jena High attempted to enter a party uninvited. They were told to leave, which they refused, and a fight broke out. While several white party goers were involved, none were students at Jena High. The next night at a local convenience store, one of the white men involved at the Fair Barn fight was involved in an incident with three black students from Jena. This fight once again didn't involve any white students from Jena High School.

It is important at this point that several media distortions which have been passed off as fact are corrected. Justin Barker, the young man that the Jena 6 assaulted, was in no way involved in any of the off-campus fights nor did he in any way engage in accosting any of his assailants. Mr. Barker didn't point a rifle at Mychal Bell at any time, unlike what sensationalistic accounts in the press regarding the December 2 incident at the convenience store have documented. In fact Mr. Barker has no criminal record at all unlike Mychal Bell or Robert Bailey. When one has digested these facts any and all justification for the coming actions of the Jena 6 melt as snow in the face of the sun.

On December 4 the assault that spawned this national sensation took place. Mychal Bell, a football player for the school, walked up to Justin Barker and hit him in the head from behind. A group of 8-10 black students joined in the vicious gang assault that saw Mr. Barker pummeled while on the ground and unable to defend himself from even the first punch. While he suffered painful injuries,

thankfully Mr. Barker has recovered from most of these injuries, though he suffered from headaches six months after the attack and was blind in one eye for three weeks.

Six black students were charged with attempted murder as Justin Barker had no chance at all to defend himself, and was repeatedly pummeled while on the ground and not moving. This outraged the black community in Jena and became a sensation with the press as the case went forward. The howls of injustice went up as the "6" were seen as targets of a bigoted white justice system. Why were they tried as adults?, why attempted murder?, and all other manner of excuses were made for the Jena 6. What was somehow lost in the uproar was that Mr. Bell was no choir boy and had three prior convictions as a juvenile. These priors were no laughing matter either as they were for two violent crimes and a property crime, and all of this by the time he was 16 years of age. Mr. Bell was convicted and then it all hit the fan as Jesse Jackson and Al Sharpton all descended on Jena like a plague of old. The facts were lost, the truth distorted, and criminals/thugs were turned into heroes. The main truth that seemed to be lost was, that about Mr. Barker and the criminal assault that took place.

Some inconvenient facts of the case include that of Robert Bailey Jr., one of the Jena 6, and another member of the "6," Carwin Jones, caught on camera showing off large amounts of money and brand new jewelry in the wake of the legal defense fundraising effort. Mrs. Bailey, who also happens to be chairwoman of the local NAACP, is driving around in a brand new BMW. Mychal Bell's mother is also the proud



owner of a brand new Jaguar. Now one can only speculate where the money in the pictures, to purchase the vehicles, and the jewelry came from. Just as the truth about the nature and character of Crystal Mangum, the accuser in the Duke Lacrosse debacle, came out, the truth about the character of the Jena 6 and their families is coming out for all to see.

When one talks of ill-gotten

money one would be remiss if they forgot to mention the Southern Poverty Law Center and its campaign of misinformation involving Jena. # Jena, Durham and the Culture War Redefined

On October 16, the US House Judiciary staged a hearing on the case of the "Jena Six," a gang of black thugs led by hardened criminal Mychel Bell who mauled an innocent white student at the local high school last December. Among the topics discussed were extending "hate crime" legislation to permit the prosecution of minors, outlaw the hanging of nooses and the staging of racially themed college parties, as well as amending the "No Child Left Behind" law to require every public school in the country to mis-educate their students on the history of American race relations via the Southern Poverty Law Center's "Teaching Tolerance" program. No consideration was given to better protecting whites from hate crimes. While most Republicans boycotted the event, only Iowa Congressman Steve King showed up to voice his concern for the white victim, and to defend the integrity of *our* people as a whole. He was immediately scolded by Maxine Waters, a radical black Congresswoman from California who has repeatedly called the assault a "so-called crime."

This follows a month of mass media attention given to the calls of Civil Rights, Inc., to "free the Jena Six," with the white victim totally overlooked. From CNN reporting on the "racism" of the town, to the black commentators on the news networks applauding the September demonstration as the beginning of a new frontier for the "civil rights" movement, to newspapers all over the country maligning LaSalle Parish District Attorney Reed Walters, to an ESPN story expressing regret that one of the black thugs will probably be denied a football scholarship to college over the assault, it has become increasingly clear that white suffering is of no consequence to elite society. Somehow, the only source of outrage

has become the hanging of the nooses.

The political and media response is in great contrast to a 2006 case where a black stripper in Durham, NC, falsely accused three white members of the Duke University Lacrosse team of gang rape. In the midst of an election season in the majority non-White city, local District Attorney Mike Nifong responded to Al Sharpton's media campaign on behalf of the accuser by proceeding with the prosecution despite having no evidence. When commentators like Pat Buchanan and Sean Hannity expressed doubt in the stripper's inconsistent claims and called her checkered past into account, they were universally condemned for their alleged racial and gender biases. And in the end, Buchanan and Hannity have become just about the only commentators on television willing to hold the un-repentant Civil Rights, Inc., responsible for their ruinous crusade.

Such events have, in fact, become the new frontier of the "civil rights"

movement. However, they truly serve only as an example of the stakes of my generation of young white people in joining such movements as the CofCC. Since the days of Montgomery Bus Boycott, the goal of Civil Rights,

Inc. has been to compel the Federal government to adopt a policy of social engineering to impose diversity. After achieving these ends, they began to transform their movement from a superficial struggle for "equality," in favor of finally advancing the true aims of their movement: building a "new America" based on moral and cultural relativism, and instilling in every black youth a sense of entitlement.

The Southern Poverty Law Center's Teaching Tolerance program is marketed as essential to healing racial tensions. However, this program only serves to further advance the Civil Rights, Inc., cornerstones above. Obviously, their program is aimed to make white students feel guilt for the success of their forefathers, to insult the accomplishments of the Founding Fathers and those who followed in their footsteps, to degrade the culture and values of white Americans, and to instill in us the false concept that the promise of the Declaration of Independence can only be achieved



through surrendering white Christian culture to the melting pot. Meanwhile, such a program only serves to foster in minorities an even deeper hatred of white America, and to further their sense of entitlement. South African

schools have a similar curriculum, and it is used to justify the genocide the black population is carrying out against the white minority.

Even of far greater consequence than welfare programs, or of affirmative action, is the influence that gangster rap culture holds over black youth. They are told to use narcotics, to sleep around and maybe rape women if they can't "get any," to steal and kill, and that law enforcement is the "bad guy." School teachers most often can't discourage this lifestyle, and nowadays the third or fourth generation of such a culture is being born. It was these trends that compelled me to join the movement, and since then I've been amazed as I've found everyone from Major Patterson to George Wallace envisioning our current situation decades ago.

Both in the cases of the false accuser in Durham and the gang of thugs in Jena, we find that the Civil Rights, Inc., has added a forth corner stone: sometimes, actions shouldn't have consequences. Whether you're a troubled stripper, disadvantaged and forgotten by society; or you're black in LaSalle Parish where white students enjoy the company of their own people, and David Duke carried over 62% in a US Senate race, society is always to blame. Maybe if we let more non-White immigrants come in, and the government pays its welfare queens to have more illegitimate children, and the schools teach students about how bad white people made this country, then maybe we can move past our differences and live in brotherhood in our "new America." After all, isn't South Africa better off?

election in which newly registered Latino voters made the difference.

While Republicans will be having problems winning the vote for their candidates, the Democrats will face a challenge from a different direction. New Democratic voters will identify more with the agenda of the Rainbow Coalition than with that of the Democratic Leadership Council. So far, the Democratic leadership has kept the situation under control. No less a personage than the leading neoconservative ideologue Robert Kagan, writing in the April 29, 2007, *Washington Post* offers assurances that Barack Obama is an "interventionist" who wants a strong military. What that means is that Obama as President would be ready to defend Israel.

Nonetheless, the anti-Zionist campaign within the Democratic party has begun. Leading it is none other than America's most politically correct Christian, former President Jimmy Carter, who recently published a book accusing Israel of being an Apartheid regime. This came not long after publication of the Mearsheimer-Walt report, by two professors at Harvard's Kennedy School of Government, which maintains that the war on Iraq was fought on behalf of Israel. The growth of an anti-Zionist faction in the Democratic party could be very damaging to its financing, but numbers will one day overwhelm money. Eventually the Third World socialist faction will dominate the Democratic party.

Republicans, also, will be alarmed

by this development. If and when they come to us for support, we should tell them that we had warned them of this development only to be denounced as know-nothings, nativists, and racists. When others, from both parties, begin to lament the declining support for Israel, we need to ask them why we should spend a trillion dollars on the defense of Israel when they have always refused to spend even one percent of that amount to defend our southern border.

We have arrived at a dark and gloomy place where we are tempted to mistake any falling meteor for a guiding star. Especially now, just before a Presidential election year, we are tempted to waste more time, money, and effort on some candidate even when we know that candidate cannot win. Right wing people make a mystique of leadership and are

In this gloom, we need to brighten the corner where we are by developing the organizations, publications, and media efforts which we do control. Leadership will then arise on its own. We should not look elsewhere for it. It must arise from our own ranks. No one else will save us. If it is to be done at all, it must be done by ourselves alone.



## Confederate Battle Flag on U.S. Nuclear Submarine


In 1960, there were fifteen of us submarine sailors in San Francisco teaching the Turkish Navy about subs.

When we finished and took down the U.S. flag and raised the Turkish flag, we had no new orders. The XO told us that a place called Pascagoula, Mississippi was fixing to build a nuclear fast attack submarine named U.S.S. SNOOK (SSN-592), which at the time was the deepest and fastest submarine ever built. Ten of us volunteered to go to Pascagoula for the commission crew.

One of my friends told us, as we were sailors and loved to party, we did not need to go to Mississippi, as it was a dry state and alcohol was illegal.

We drove to Mississippi and checked in at the Ingels Shipyard and weretold that there was no Navy there in 1960. So they told us we could get \$16 a day extra to buy food and find a place to live.

I found two lounges that served what I needed in the dry state and bought me a newspaper. A large man sat beside me and asked if I was a new sailor in town and needed a place to



stay. I said "no thanks," but he offered me a cot on his front porch anyway. He then opened his coat to show me his badge. He was the Sheriff of Jackson County, Mississippi.

The next couple of years, my shipmates and I found out about the friendly people of Mississippi. I was the first sailor of my group to marry a Mississippi girl, Joselyn Magee from Marion County. Then there were fifteen of us on the SNOOK that got married there.

The people of Mississippi welcomed us with open arms and were so friendly to us that we wanted to give

them a proper farewell when we sailed to take the SNOOK to San Diego.

The local chain motel flew the

Confederate Flag along with the U.S. Flag on their poles.

Several of us shipmates acquired one of their large Confederate flags and properly attached it to our raised periscope of the SNOOK to let Mississippi know that we loved the South.

It was beautiful flying high as we departed Mississippi waters.

Later, we received a radio message from a high-ranking Navy Admiral to remove the flag immediately. He simply added that the Confederacy did not have a nuclear submarine in their Navy.

We the sailors of the USS SNOOK were proud to fly the flag.
